I have noticed that the railroad ties alongside the road between A building & the villas are pretty beat up. Wondering if we could replace those. Darryl also mentioned there is a wall by K building with railroad ties that should be replaced. Wondering if we could do that with landscaping stones.

Once the board decides on all of these plantings, I will go to Ace & purchase these plants so they will deliver them. I'd like to do it all at once. Including the front entryway flowerbed.

We did some cleanup this past week of some flowerbeds in common areas. A few owners helped out. Thank you.
