American Coastal which is \$141,754.17 per year with \$2,500.00 AOP deductible, 2% hurricane & 3% sinkhole deductibles. After Board discussion, Carol Lovejoy made a motion to go with American Coastal without environmental impairment liability option. Pat Altyn 2nd the motion. All in favor 5. Opposed 0.
- 4. Bonus for maintenance man. Bob Hutchinson made a motion to give Patrick Dorch a \$3,000.00 bonus. Pat Altyn 2nd the motion. It was mentioned how much work he did from the hurricane clean up. He saved us \$3,900.00 by maintaining the bait boxes instead of hiring it out. Also saved us \$1,800.00 by dismantling the island. Walter Babst stated that one weeks pay should be sufficient.
