5. Committee Reports:

Pool: David Martin reported that the pool area is quiet. The pool cooler is functioning well, keeping the pool a comfortable 86 degrees.

Building: Bob Hutchinson reported that stucco repairs to certain buildings have been delayed because of rain. He also recommended that the BOD file an insurance claim for repairs to building H, due to wind damage. Bob also stated that because we were pleased with the work done by Watertight Roofing, we will use them for repairs on Villa 5.

Landscaping: A discussion will be had with the landscaper about better timing. A recommendation that we look for another landscaper was suggested. Notifications will be sent to residents using their own sprinklers.

Finance: Jeff Schram reported that we finished the month \$2,666.72 in the hole. Year to date we are in the hole \$4,085.33. The main culprits are the legal fund and the water fund. We budgeted \$5,000.00 and so far we have spent \$7,572.00 for our attorney. I know we have a lot

of things going on here such as Windrush North. We will have to budget more next year. The water fund is interesting. Comparing to past years, we have spent \$1,400.00 more per month for the month of January through April. However, this month we came in \$1,084.00 less than 2018. We will have to budget more for water as well next year.

Phone Books: Please let committee know of any changes.

Welcome Packets: Carol Lovejoy is seeing that new residents get a welcome packet.

6. Volunteer Groups:

Social: Fourth of July party is planned for 5 pm at the clubhouse.

A motion to ratify the stucco repairs made by Sam Swinton was made by Carol Lovejoy, seconded by Bob Hutchinson. Carried unanimously.

A motion to ratify general repairs to buildings B, G, K and O by Homeworks of Holiday was made by Bob Hutchinson, seconded by Pat Altyn. Carried unanimously.

A motion to approve the removal of a wall in 627 was made by Carol Lovejoy, seconded by Bob Hutchinson. Carried unanimously.

The pool fence will be installed on July 15, 2019 and take approximately two days or less to install. It is 54" high.

8. New Business:

Approval was given by the Board of Directors's to the finance committee to begin phase 2 of the CD's.
